



**CITY OF SYCAMORE  
BOND FOR UTILITY WORK IN RIGHT OF WAY**

We, \_\_\_\_\_ as principal, and \_\_\_\_\_ as surety, are held and firmly bound to the **CITY OF SYCAMORE**, a Municipal Corporation of the State of Illinois, in the penal sum of ten thousand dollars (\$10,000), lawful money of the United States of America for the payment of which said sum, well and truly made, we do hereby bind ourselves, our heirs, executors, administrators, assigns and successors, jointly and severally, for this payment.

The condition of the above obligation is such that:

**WHEREAS** the above-named principal has made or will make application for work which involves utilities located within the City of Sycamore right-of-way (which includes streets, parkways, and alleys) which work is to be performed between, January 1, 20\_\_\_\_, and December 31, 20\_\_\_\_, and

**WHEREAS**, the City of Sycamore Municipal Code, Title 7, Chapter 7 Section 3 requires that the principal shall give bond to indemnify the City against any loss arising because of the failure of said principal to comply with the laws under which such permits are granted, or any rules or regulations pertaining thereto,

**NOW THEREFORE**, if said principal shall be granted a permit for construction within the City right-of-way in accordance with said application, and shall and will during the term for which permit is granted aforesaid, faithfully keep and observe all ordinances of said City now in force or that may be hereafter passed and in force during the term of such permit in regard to the business to be carried on under such permit, which ordinances are hereby by reference thereto made a part of this bond as fully and completely as if expressly recited herein, and shall pay any and all fines and costs that may be legally imposed upon for any violations of such ordinances, then this obligation shall be void, otherwise to remain in full force and effect. It is understood, however, that prior to the release of this bond, the principal shall, on each site where the principal has worked, restore, remove, clean, fix, or repair any damage caused during the course of any excavation to the satisfaction of the City.

This bond expires on December 31, 20\_\_\_\_, unless renewed by a continuation certificate.
